# MYXONIL

Liquid Premix of Feed Additives / Oral solution

Mixture Immunostimulant & Organic acids

**COMPOSITION: Each 1 litre contains**

Yeast extract (dried *Saccharomyces cerevisiae* cell wall) , MOS /Mannan oligosaccharides , Beta 1.3/1.6 glucans , Garlic extract (Diallyl disulphide) , Oregano extract (Carvacrol, Thymol) , Sorbitol , Inositol , Betaine hydrochloride , Formic acid , Propionic acid , Citric acid , Orthophosphoric acid , DL-Malic acid , Lactic acid , Calcium lactate , Sodium formate , Vitamin B1 Thiamine mononitrate , Vitamin B2 Riboflavin 5'- phosphate sodium , Vitamin B6 Pyridoxine hydrochloride , Vitamin H Biotin , Propylene Glycol /1,2 Propanediol , Demineralized water

**Indication:**

- mixture of immunostimulants and organic acids is indicated to help in supplying the target animals with high level of immunity and growth rate –resulted in improving herd uniformity and increasing Feed Conversion Ratio.
- improve egg production and hatchability in layers – and improve meat production in Broilers and large animal reflecting on increasing body weights.

**Dosage and Administration:** For oral administration via drinking water

Chicks / Broiler: 0.2-0.4 ml / L DW for 5 days

Grower / Broilers 2-4 weeks: 0.6-0.8 ml / L DW for 5 days

Layers: 0.5 – 0.7 ml / L DW for 5 days

Calves dairy and Cattle: 20 - 30 ml / head for 5-7 days

Lamb, Goat and Sheep: 10 - 15 ml / head for 5-7 days

Shake well before use.

**Packing:** Bottles of 40 x 250 ml per carton box, Bottles of 18 x 500 ml per carton box, Bottles of 12 x 1 litre per carton box; Can of 3 x 5 litre per carton box; Can of 10, 20 and 25 liters
